7. The District website is operating and includes information regarding Measure Q and the COC (education code section 15278) (b). This includes minutes of the COC meetings and reports issued by the COC, which will include this Annual Report following its adoption.
8. Based on the foregoing information, the Northern Humboldt Union High School District is in compliance with the requirements of Article XIII A 1(b)(3) of the California Constitution.
